#### (a) APPLICATION REF: 20/505427/OUT

# PROPOSAL: Outline planning application for the erection of 6no. dwellings with associated parking provision, utilising existing highways access with pedestrian access, landscaping and other ancillary works. (Access being sought)

#### ADDRESS; Land at Pond Farm Road, Borden, Kent ME9 8LL

It was **RESOLVED** to object to the application.

There are incorrect statements made in the application that invalidate the claims that the application is suitable for the highways access proposed. Highways safety issues will be caused by the proposed access and this would exacerbate an already dangerous junction. The number of personal injury accidents quoted in the application is significantly lower than that in the public records.

This road is used as a 'rat run' during peak hours and serves the local primary school therefore the increase in traffic would cause further highways issues.

The parish council is also concerned about the effect on the nearby conservation area. This is a sensitive edge of an important historic area with Grade One listed church and other listed buildings surrounding the development, the character of the area will be detrimentally affected. The proposed buildings are of a modern design in complete contrast to the existing historic

buildings, they will impede the views of open farmland and the view of the rear elevations of the listed buildings. The approach to the conservation area will be marked by a modern development which will alter its context in the village street scene.

The development is not close to transport links, the train station is some distance away, the bus route is infrequent and there are no footways or cycleways in this area. This does not support the sustainable development criteria. There are no local amenities within easy reach of the proposed development, such as shops and there is insufficient healthcare providers in the wider area.

Borden area has a significant need for affordable housing, including bungalows for its growing elderly population. The houses proposed are large executive homes which doesn't meet the local need.

#### ADDRESS: 66 Maylam Gardens Sittingbourne Kent ME10 1GB

It was **RESOLVED** to object as this is not in keeping with the open plan style of the development. The parish council is opposed to the removal of the trees.
